Part I – Public Session

121. To accept Apologies for Absence (*agenda item 1*).

Apologies for absence were received from Cllr Graham Hawes, Cllr Steven Evans arrived at 6.35 P.M.

122. To receive Declarations of Interest (*agenda item 2*).

Declarations of interest were received from Cllr Doug Richards who declared a personal interest in respect of Item 6 as he resides in South Lane.

123. Confirmation of the Minutes (*agenda item 3*).

The minutes of the meeting held on Monday 15 March 2010 have been before the Full Council by which they were duly approved and adopted. These minutes were signed by the Chairman of the Amenities Committee.

124. Adjournment (*agenda item 4*).

126. Street Lighting – South Lane (*agenda item 6*).

Following recent requests for additional street lighting in South Lane, members considered the replacement of 10 existing yellow lights with new white lights at a cost of £195.00 + VAT per light and it was:
