

Replacement CCTV Camera at Coronation Gardens

Executive Summary

To consider the replacement CCTV Camera for Coronation Gardens Car Park.

Recommendation to Council (14 October 2019)

That Members agree to the request for a replacement CCTV Camera at Coronation Gardens at a cost of £2,766.54 (excluding VAT).

1. Purpose of Report

- 1.1 Members to consider the request to replace the existing CCTV camera at Coronation Gardens Car Park.

2. Background

- 2.1 The existing CCTV Camera located above the recycling bins in the Coronation Gardens Car Park was one of the first CCTV cameras purchased by the Council. The Camera was updated when we change from our original CCTV provider to Prime One Maintenance Limited approximately 4 years ago. After this upgrade the quality of the images produced was adequate at the time.
- 2.2 There has been an increase in the amount of rubbish being left alongside the recycling bins. This is considered by Guildford Borough Council's Joint Enforcement Team (JET) to be fly tipping. The cameras images are not of a suitable quality to be able to read car number plates or provide adequate facial recognition to assist the JET in making any enforcement decisions.

3. Financial Implications

- 3.1 Prime One Maintenance Ltd have provided a quote (QT/KT/975) for £2,766.54 (excluding VAT) to replace the existing camera with a better quality twins lens camera. The monthly maintenance of the camera would be incorporated into our monthly maintenance agreement with Prime One Maintenance Ltd.

4. Implications on Crime and Disorder

- 4.1 The Crime and Disorder Act 1998 (Section 17) requires a parish council to consider the crime and disorder implications of any decision. The recycling bins at Coronation Gardens are subject to repeat fly-tipping and occasionally arson. This camera will enable the JET Team and Surrey Police to proceed with prosecutions relating to fly tipping and arson.

5. Implications on Biodiversity

- 5.1 The Natural Environment and Communications Act 2006 (Section 40) requires parish councils to consider the impact any decisions will have on biodiversity. There are no direct biodiversity implications arising from this report.
