# **106.** To accept Apologies for Absence. (agenda item 1)

Resolved upon consideration that the fourth draft budget for 2020/2021 be approved and the confirmation of the Council Tax Base figure from Guildford Borough Council be noted.

#### 114. New Ex-Shipping Container – Carrington Recreation Ground. (agenda item 9)

Members considered a report regarding the purchase of a new ex-shipping container to provide storage provision at Carrington Recreation Ground and it was:

#### Resolved upon consideration that:

- i) the quote from Cleveland Containers to purchase a new 40ft shipping container for at a cost of £9,940 + £1,988 VAT = £11,928 be agreed;
- ii) the associated ground works at a cost of £1,000 + £200 VAT = £1,200 be agreed, and
- iii) a planning application be submitted as required.

#### 115. Kitchen Replacement - Harpers Road Recreation Ground Scout Hut. (agenda item 10)

Members considered a report to replace the kitchen at the Harpers Road Recreation Ground Scout Hut and it was:

Resolved upon consideration that the quote for the replacement of the kitchen at the Harpers Road Recreation Ground Scout Hut at a cost of £5,069.62 + £1,013.92 VAT = £6,083.54 be agreed.

#### **116.** Replacement Entrance Doors – Ash Centre. (agenda item 11)

Members considered a report to replace the main entrance doors to the Ash Centre and it was:

Resolved upon consideration that the quote from PROAXS Solutions at a cost of £5,840.45 + £1168.09 VAT = £7,008.54 to replace the entrance doors to the Ash Centre be agreed.

# 117. Play Area Equipment Repairs – Harpers and Carrington Recreation Grounds. (agenda item 12)

Members considered quotes from HAGS/SMP Playgrounds Ltd and Sutcliffe Play for the repairs to play equipment, manufactured by them, at a total cost of £3,743.32 + £748.66 VAT = £4,491.98 and it was:

- i) HAGS/SMP: Harpers Recreation Ground (£2,867+ £573.40 VAT = £3,440.40)
- ii) Sutcliffe Play: Carrington Recreation Ground (£876.32 + £175.26 VAT=£1,051.58)
