

Final External Auditor Report and Certificate 2019/20 in respect of Ash Parish Council SU0005

Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with Proper Practices which:

Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

External auditor report 2019/20

On 29 November 2020, we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2020. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review.

The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR.

- Information received from the smaller authority indicates that the figures in section 2, Box 9 for the current year and prior year are incorrect as they do not agree to the fixed asset register. The figures in the fixed asset register for the current and prior years are £3,612,751 and £3,618,826 respectively. The smaller authority has confirmed that new fixed asset software is being implemented during 2020/21 and that a full review of fixed assets is being carried out as the register is being transferred to the new system and so this issue should be resolved for the 2020/21 year end.
