The condition was imposed because of the nature of the development and to protect the amenities of properties and residents in neighbouring villages.

The noise assessment fails to consider any properties other than those adjacent to the site and does not take into account night time movements in the neighbouring villages. One of the routes to Henley Business Park where these HGVs will travel is along Guildford Road, Aldershot Road, Vale Road and Ash Street, all within the Ash Parish area. This will be particularly noticeable at night time and will disturb hundreds of residents. This will be intolerable and completely unacceptable.
